1. ProspectsPLUS! will:
 - a. Publish a new monthly Market Dominator each month, featuring infographics, professional copywriting, relevant direct response offers, and a professional layout, with necessary industry standard disclaimers.
 - b. Provide a web-based platform for you to optionally make changes to your Market Dominator.
 - c. Guarantee exclusivity of your carrier routes – we will not allow any other customer to order the Market Dominator in the carrier routes indicated in this Agreement, as long as this Agreement is in effect.
 - d. Print your Market Dominator on 12" x 15", 100# Coated Cover, Forest Stewardship Council certified recycled paper, and deliver it to the Post Office each month.
 - e. Prepare the required Every Door Direct Mail documentation for the Post Office.
 - f. Provide toll-free assistance with dedicated inside account managers.
 - g. Provide training materials and documentation, including webinars and industry best practices, on an ongoing basis.
 - h. Charge your credit card each month \$1.18 (plus tax, if applicable) per delivery address in the carrier route(s) you choose. In the event the USPS increases postage rates, the pricing of the Market Dominator will be adjusted, not to exceed 10%.
2. You will:
 - a. Make any optional changes to the Market Dominator within three (3) calendar days of the order notification email sent to you; otherwise, we will automatically place the current issue of the Market Dominator order for you.
 - b. Not use the copyrighted material from the Market Dominator for other purposes.
 - c. Not use offensive or misleading language on the Market Dominator.
3. This Agreement is for a term of two (2) years from the date indicated on the reverse side. After the initial two (2) year term, this agreement will automatically renew on a month-to-month basis until cancelled by either party.
4. If you wish to terminate this agreement early during the initial two (2) year term, a \$300.00 early termination fee will apply.
5. If we are unable to charge your credit card for a Market Dominator order, we will notify you. If we still cannot process your order within ten (10) days, this Agreement will be terminated. If this occurs during the initial two (2) year term, it will be deemed an early termination of this Agreement, and you will be charged a \$300.00 early termination fee.
6. Upon termination of this Agreement, the carrier routes indicated will be re-sold to other customers.
7. This Agreement is governed by the laws of the State of Florida, without reference to its "Conflict of Laws" rules. You consent to the exclusive jurisdiction of the State and Federal courts located in Sarasota, Florida, and you waive to the fullest extent allowed by law the defense of an inconvenient forum to the maintenance of any action or proceeding. In the event there are any claims for damages and/or suits, the maximum liability to ProspectsPLUS! shall be limited to the total amount of one month's subscription price paid by the Member.
